1. Heading/Title of the bid document (at cover page) to be read as under:

- 2. Note. 3 of Clause 2 (qualification requirement) of Vol. I (Page 6) to be read as under:

Parties with past history of delivery of non-acceptable quality of coal, violating delivery schedules in a major way, refusal to supply under any pretext, raising disputes without any reasonable basis, raising disputes with malafide intent may be debarred from participation or their share of quantity may be reduced.

3. Sub Option A3 of Clause 4.9 (basis of biding and options) of Vol. I (Page 10) to be read as under:

Sub Option A3: Imported/Domestic coal delivered to the plant, firm price basis: For this option the basis of bidding is mentioned in Annexure-XVII. <u>Clause 4.9.1. to 4.9.4.</u> (both inclusive) are not applicable for this option.

4. Note (ii) of Clause 4.9.1. F (Standard/nominal railway freight) of Vol. I (Page 11) to be read as under:

This element will be eligible for variation in GST and revision of Railway freight by Indian Railways on the date of supply. Double taxation if any to be account of bidder.

5. Clause 4.9.2. of Vol. I (Page 11) to be read as under:

In case of any change in tax rate structure on the date of supply with respect to prevailing at the time of bidding, same will be admissible for reimbursement. The tax rate structure applicable on the date of supply will only be accepted and has to be based on the credible supporting evidence. Double taxation, if any, will be to the account on the bidder. In case taxes actually paid by the bidder are with a rate lower than on the date of supply, the reimbursibility will be applicable to the lower taxes that are actually paid. This is applicable for option A1 (6300 GAR) and A2 (5800 GAR).

### 6. Clause 11 (Resolution for unforeseen situation) of Vol. I (Page 11) to be read as under:

Every possible care has been taken by NPL in preparation of this Bidding Document by considering and including various scenarios and situations. However, there may arise any unforeseen situation which has not been included in the Bidding Document. Each Bidder is deemed to have authorized NPL to consider such situation as and when it arises or is brought to the notice of NPL in a suitable manner considering its obligation to PSPCL/ PSERC as well as practical aspects/ good practices. As a first step, attempt will be made to resolve the issues between NPL Fuel Sourcing and the Contractor. Bidders are encouraged to get clarified ambiguities if any.

#### 1. BILLING AND PAYMENTS FOR COAL UNDER OPTION-A3

The Bidder will submit the bills/invoice Lot wise completion of a Lot in triplicate based on Coal delivered to NPL. The payments will be released as per the following procedure: -

The Bidder will submit the bills/invoice Lot wise in triplicate to NPL on below address or respective power plant in Punjab from where the PO would be issued under this tender process

The payments (eligible/undisputed) will be made within 30 days of

- I. Receipt of undisputed invoices along with credit note for adjustment of quality, quantity and other if any.
- II. Receipt of reports along with all supporting documents by NPL Fuel Sourcing
- III. Valid Contract Performance Bank Guarantee.

#### whichever is later amongst (i), (ii) & (iii) as above.

Following supporting documents as applicable to be submitted along with the invoices:

- A. Rake wise analysis of Coal quality at loading point (by IIAc).
- B. Rake wise analysis of Coal quality at unloading point issued by NPL TPA.
- C. NPL rake wise weighment slips in original (with readings of Gross and Tare).
- D. Copy of RR (Railway Receipt)
- E. E-way bill (appropriate form) for each rake.
- F. Ultimate and Ash constituent analysis of any one rake of the Lot at loading point (by IIAc).

#### 10. Additional terms for coal from domestic source under option-A3:

- 10.1. Loaded from inland siding with NPSB as destination.
- 10.2. Blending of low grade imported coal with Sulphur/reject/slurry is not permitted.
- 10.3. Minimum quantity to be offered is 10 rakes per month.
- 10.4. Size control: Demurrage if any at unloading end on to the contractors account.
- 10.5. NPL may require, supplier to demonstrate sourcing of coal to its satisfaction.
